# Event Summary: FOCA AGM & Spring Seminar

held Saturday, March 4, 2023



We titled our event "Coming out of our Shells" as we return to face-to-face events (since this was our first in-person Annual General Meeting since 2020). However, Mother Nature's best efforts made travel challenging for many that day! Nevertheless, FOCA's Annual General Meeting (AGM) and Spring Seminar was held by webinar and in-person in Thornhill on Saturday, March 4, 2023. We had about 60 attendees at the Bayview Golf and Country Club and another 150 on the webinar, making this one of FOCA's largest meetings to date; fitting for our 60<sup>th</sup> anniversary year!

Board President Ian Crawford, gave some historical context, noting:



We are celebrating 60 years since the creation of FOCA as a province-wide organization dedicated to waterfront property owners, and dedicated to thriving and sustainable waterfronts. This organization started with 40 associations who met in Toronto 60 years ago. Now we have 525 member associations that represent 50,000 member families. The issues that brought FOCA together originally aren't that different from the topics that consume us today: water quality and environmental concerns, development and planning, taxation, safety and rural services.

We are planning a <u>special event celebrating FOCA's 60</u> <u>years</u> which will give us a chance to revisit some of FOCA's accomplishments and thank the volunteers who have shaped this organization over the decades. For now, please save the date: **Saturday, September 23**<sup>rd</sup>. Stay tuned to the <u>FOCA Elert</u> as we reveal more about this event in the coming months.

Since 2020, our organization has been guided by the 6 **strategic priorities** outlined by the Board of Directors, which have carried FOCA successfully through the last few extraordinary years. Those priorities are:

- promoting healthy lands, lakes and rivers
- serving lake and road associations
- advocating for responsive government
- championing affordable and safe rural living
- building organizational capacity and strategic partnerships
- and, fostering community in rural Ontario.

lan thanked the volunteer **FOCA Board of Directors** whose thoughtful input and advice continues to make FOCA a strong voice for waterfront landowners. FOCA's directors represent large and small associations, on the Great Lakes and the inland lakes, from all parts of the province. The dedication of <u>all</u> our volunteers has helped to steer this organization, year after year, and decade after decade.

And this year your Board of Directors will be undertaking a **strategic renewal process**, which is an opportunity for us to reflect on where the organization has been, refresh and refocus our priorities for the coming years, based upon our collective experiences and including the feedback you provided to our extensive 2022 member surveys.

## **Updates for our Member Associations:**

We know a great deal **about our member Associations**. We know that many of them are groups with less than 50 members, though some have more than 1,000 member families. We know our Road Associations look somewhat different than associations that are strictly lake and waterfront groups. We know what your peers are charging in annual dues – and it's a spread between the price of a good bottle of wine, to the price to fill your gas tank to get to the cottage – or even more, if you're also paying to maintain a private road. When the Board President last spoke to members at the 2022 FOCA Fall Seminar, he said the Board of Directors was responsible to regularly review and revise all revenue lines including our **annual FOCA membership dues**, to ensure we are appropriately funded to serve your needs. Despite the recent impacts of inflation, and our full staff compliment which is serving you so well, the Board of Directors has decided <u>not</u> to raise the annual Association Membership Fee at this time. It will remain at a \$125 base fee, plus \$4 per member. This amount is now subject to HST, as the Board President announced in a January email to membership, and you will see this reflected on your renewal invoice this year.

Despite the great contributions of our sponsors, as a membership organization we are primarily supported by membership fees, together with the contributions of our Individual Supporters and donors, alongside program funding in the form of program funding that we work hard for year-after-year, and remaining smaller sources of revenue including fee-for-service offerings, such as event registrations.

Your annual investment in FOCA enables our year-round work on behalf of associations and waterfront Ontario. In the context of the Economic Report FOCA released last year, about the impact of the significant \$11.44 billion-dollar annual spend by our waterfront Ontario community – we are certain you will agree that your small annual contribution to FOCA goes a long, long way. FOCA's work involves our government advocacy, our programs, our publications and events, and the educational outreach we do to reach those who are new to cottage-country, to help them understand their important role in the future of waterfront Ontario.

Next, FOCA's Executive Director Terry Rees spoke, providing more details about FOCA's programs, as well as recent and emerging priorities and hot topics for waterfront Ontario.

# Words from the Executive Director: FOCA Programs, Priorities, History & Hot Topic Updates



From our surveys – and from looking around the lake – we know things are changing; two-thirds of respondents to our 2022 survey said that their lake property is capable of year-round use, and an additional 8% of survey respondents were planning to winterize in the future. We also know from our 2022 survey that 70% of waterfront properties now have 4-season road access. Over half of respondents are on a private road, while about 10% are on an island or otherwise water-access only. The most recent statistics from the Municipal Property Assessment Corporation (2022) suggest the water-accessonly percentage might be as much as 13% of all developed waterfront properties. And 1/3 of respondents told FOCA increased use of their waterfront property is limited by digital access or services, such as high-speed internet or cell service.

For 60 years, FOCA has been the voice of waterfront Ontario. We are accountable to you – our members – and have worked hard throughout the decades to represent your interests. **During the 1980s** FOCA fought for government action on the issue of acid rain, (were a large voice pushing for reductions in harmful acidic emissions) and lobbied to stop the use of toxic Dombind as a road-dust suppressant. FOCA also secured the <u>municipal voting rights</u> of waterfront property owners in their cottage ridings, and brought the attention of the Provincial Auditor and Ombudsman to the shortcomings of Ontario's <u>property taxation system</u>.

Over the years, FOCA has advocated on behalf of <u>rural source water protection</u>, <u>fisheries habitat</u>, landowners' rights during <u>mining and aggregates claim-staking</u> as well as <u>water management planning</u>, <u>forestry planning</u> and <u>land use</u> including lake capacity assessments. We have lobbied to secure the ongoing funding for the <u>Lake Partner Program</u> of volunteer water monitoring of Ontario's inland lakes, to protest <u>MPAC assessments</u> and the elimination of the seasonal rate class of <u>electricity customers</u> – each of which have resulted in multi-year phase-ins of legislated changes, to drastically limit the annual impacts on individual families' bills.

FOCA developed a <u>boating hazard marker program</u> approved by Transport Canada, and has assembled the most comprehensive risk-management program for volunteers in rural environmental groups, through the <u>FOCA Insurance Program</u>. Almost 450 associations across Ontario now protect their volunteers through this cost-effective liability insurance program, a unique FOCA offering. And the <u>CottageFirst</u> group insurance program is available exclusively to our FOCA member families, providing excellent coverage for cottages, homes, cars, boats and more.

In recent years, FOCA has released reports on <u>septic re-inspection programs</u>, <u>lake planning</u>, and <u>short-term rental</u> that are used by our member Associations as well as our municipal partners to chart the course in rural Ontario. And, we have championed the importance of lake associations in rural communities throughout the past three pandemic years, advocating for inclusion and tolerance, and working to mitigate sentiments that divide permanent and seasonal populations. Finally, we have served you – our member Associations – throughout the pandemic, by turning our own office operations on a dime to become seamlessly digital, and by supporting your need to keep local association business running by offering FOCA's own Zoom platform to accommodate many of your annual meetings.

Our social media channels have exploded over the past year, enabling FOCA's messaging to reach three-quarters of a million people in 2022. We are spreading the word about sustainable waterfronts, and the important role of volunteer associations in rural Ontario. We have brought you speakers, recordings, and seminars on far-reaching topical issues from rural road issues to <u>cardiac safety</u> in cottage country, <u>invasive species</u> and <u>wake awareness</u>, <u>cottage succession planning</u>, and <u>environmental threats</u> facing waterfront Ontario.

# **Additional Hot Topic Updates:**

**ONCA Update:** One of our 2022 events was a spring webinar with Community Legal Education Ontario on the topic of ONCA – the Ontario Not-for-profit Corporations Act. After more than a decade, the Ontario Not-for-profit Corporations Act, or ONCA, was finally proclaimed in 2021. If your association is incorporated in Ontario, you have until October 2024 to fully transition to the new rules. It is time to review or update your bylaws, to comply with ONCA. FOCA is reviewing our own bylaws, and if any changes are needed to bring our bylaws into compliance with ONCA, members will vote on them at the 2024 AGM. You will want to do the same with your own incorporated association, as it may require a special resolution vote to make changes at your next AGM; consult your existing bylaws for more information, and review the **member webinar** FOCA held with Community Legal Education Ontario last Spring. We have had a few questions about ONCA compliance from our members, including: "How can a nonprofit get a CompanyKey if the address they have isn't working on the online Ontario Business Registry?" The Ontario Nonprofit Network has posted detailed information online, including a link to order your CompanyKey. To figure out if you've got the right address for the corporation to match the government file, you may need to pay to order a Corporate Profile, and further file a Notice of Change through a government-authorized service provider, if the address they have is wrong. However, the OBR requires that you supply the mailing address as well as postal code of the corporation. "What can a nonprofit do if it uses a PO Box as its address?" Our contact at CLEO notes this is an outstanding problem, unless you can give the address of an accountant or lawyer's office that works with the nonprofit, or a community centre or shared space that offers this service; the other alternative is to give the personal address of a director or officer – though this will not work for everyone.

The **Municipal Property Assessment Corporation** (MPAC) has announced there will be no new increase in valuations at this time, and property taxes will continue to be calculated based on January 1, 2016 values until further notice.


The **Underused Housing Tax** (or UHT) is an annual tax of 1% of your property value levied by CRA for non-resident owners. This new tax only applies to non-Canadian residents, who submit a UHT form by April 30 annually even if they are exempt from the tax. Residents in seasonal-only properties may fall under one of the exemptions. If you do not have a Canadian Social Insurance Number (SIN) you must file using an Individual Tax Number (ITN) which you can apply for online. We are seeking some clarification about how to apply while awaiting an ITN and also what to do if you don't have a postal code for your property. FOCA has been following the issue of "**floating accommodations**" or "camping over water" for some time now, and has participated on a committee led by the Georgian Bay Association and the Gloucester Pool Cottagers' Association. Efforts continue with Transport Canada to tighten up their rules and enforcement of what is a "vessel", and the latest development is a posting by the Province related to the "camping" aspects. Of course, **Bill 23** has also been a hot topic, as the Province wrestles with the best way to deal with housing affordability and availability issues – which FOCA feels strongly cannot come at the expense of our ecosystem services, and without adequate due process. Transport Canada is set to launch a public comment period soon, through their "Let's Talk Transportation" online portal, about proposed **mandatory wearing of personal floatation devices** (PFDs) in response to concerns from water safety advocates and law enforcement about boating fatalities amongst people not wearing PFDs. We remind you that FOCA's 2022 Report on the Economic Impact of Waterfront Property Owners contains





details about the \$11.44 billion annual spend by this community, which supports 157,000 jobs across the province, mostly in the local waterfront communities themselves. There are some figures broken out in Appendix D of the report, by upper-tier municipality, so you can give some high-level information to your own municipal partners about the number of waterfront properties in your own community, and the estimated impact of their spending.

# **FOCA Program Highlights:**

**Invasives – Boater Pathways:** FOCA supported the amendment to the Invasive Species Act by the Ministry of Natural Resources and Forestry, that regulated watercraft (including: boats, canoes and kayaks) as a potential carrier of invasive species. This past year, FOCA informed lake users of these new regulations and how they will help us prevent and slow the spread of invasive species through our website, social media, newsletters and a webinar. IsampleON Program: IsampleON stands for Invasive Species Awareness Monitoring Program & Lake Education in Ontario. In 2021, FOCA launched the IsampleON program with our colleagues at the Invasive Species Centre (or ISC) and we were pleased to be able to continue the program in 2022. The intent of the program is to do targeted outreach, education and sampling for invasive mussels and spiny water flea in lakes on the Canadian shield. 29 lakes were selected from within FOCA's membership with over 50 volunteers representing those lakes. The volunteers collected 3 water samples + 1 eDNA sample from their lake and sent them back to the ISC for lab analysis. Volunteers also posted and shared information about invasive species prevention in their community. Thank you to the volunteers for their hard work and dedication to the program! We know early detection is essential to protect against the negative impacts aquatic invaders can have on these key ecosystems. **Green Shovels – Phragmites Program:** For the past two years, FOCA has worked with conservation partners on the Green Shovels Collaborative. The Collaborative is a group of organizations with a shared interest in protecting nature and the economy. Through this alignment, FOCA has been able to fund many onthe-ground Phragmites projects aimed at addressing invasive phragmites through education and outreach, control, management, and eradication. **Asian Carps:** FOCA also works with the Department of Fisheries and Oceans Canada to educate everyone about the threat posed to the Great Lakes by Asian Carps, so that our members can be part of an early warning system to protect our waterways from these invaders. **FireSmart:** In 2022, FOCA worked with the MNRF to educate waterfront property owners about wildfire prevention and FireSmart. You may have noticed articles in the <u>Lake Stewards Newsletter</u> and <u>Elert</u> about Waterbomber safety, and not to fly drones within 9 km of a wildland fire area as firefighting aircraft cannot share airspace with drones. Cottage Succession Program: FOCA and estate lawyer Peter Lillico have been teaching families about cottage succession planning for the past decade! Our traditional in-person seminars shifted to digital over the past couple of years. These events are free to FOCA members, and the slides are shared with registrants after the events. And as a reminder, if it is inconvenient for you to attend, you can always purchase access to the digital recordings to watch at your leisure. Thank you to our member associations who were the local hosts in 2022. We already have several seminars scheduled for 2023. **Lake Partner Program:** The Lake Partner Program is our long-standing citizen science initiative between FOCA's Lake Stewards and the Ministry of the Environment, Conservation and Parks which analyzes annual water samples and Secchi depth recordings taken by over 700 volunteers to track long-term trends in our waters. We appreciate all the fantastic volunteer effort that each of you as volunteers contributes to this program! FOCA 2023 AGM & Spring Seminar – Event Summary for Members

The 60th FOCA Annual General Meeting of Members was chaired by Ian Crawford, FOCA Board President.

Quorum (25 Member Associations) was met. Treasurer Daryle Moffatt presented the Financial Statements and budget projections. All items of business passed:

- Approve the Minutes of FOCA's 2022 AGM
- Receive the Financial Statements for the year ended September 30, 2022
- Authorize the FOCA Board of Directors to appoint Clarkson Rouble LLP as FOCA's auditor for the 2022–2023 fiscal year
- Amend item 6.2 of the FOCA bylaws to read:
   "A Director who has completed 2 consecutive terms of office shall not be eligible for re-election for one year following the
  - completion of their second term as Director." Also, "The Board of Directors at its discretion may extend the term of the Director serving in any Officer role for an additional year, to a maximum of two additional years."
- Elect the slate of Directors recommended by the FOCA Governance & Nominating Committee
- Motion to adjourn the AGM.

# We also awarded a number of "Honourable Mentions" for 2022 Association accomplishments:

**Kamaniskeg Area Property Owners** was honoured for holding their 10<sup>th</sup> annual Poker Run in 2022; altogether, they have raised just shy of \$150,000 over the past decade, to help the local hospital foundation fund critical equipment.





**Menominee Lake Association** was honoured for participation in several citizen science and monitoring programs, and community events including reviving their annual BBQ and boat parade. The association made a special "call-out" to their youth volunteer Hanna Marshall who led some of the environmental programming.

**Kennisis Lake Cottage Owners Association** was honoured for a "Dock Etiquette" awareness and education program as well as an "Abandoned Dock Initiative" to identify docks that had been left (or drifted) to public areas around the lake, becoming unsightly hazards to navigation. 11 abandoned docks were corralled in a bay adjacent to a public boat launch. 27 volunteers dismantled the docks, salvaging what they could and taking 10 trailer loads of debris to the local landfill for disposal.





Talpines Property Owners Association was honoured for creating a Community Garden beside a children's playground to engage new families during the pandemic, and create a place for people to connect with each other and nature in a safe way. One of the aims was to support the work of Truth and Reconciliation, and a local neighbour agreed to be their Indigenous Advisor for the project. She suggested planting the four Sacred Medicines of the Anishinaabeg in the garden: tobacco, cedar, sage, and sweetgrass. They also planted the Three Sisters of Haudenosaunee origin (corn, beans, and squash) as a model for building community, because the Three Sisters are all different but they cooperate in a way that produces more food than if they were planted alone. Over the year they held a Planting Ceremony, National Indigenous Day Social, Harvest Festival, and Pumpkin Carving, among other events. They secured some tree stumps which were painted by adults and kids to create a story circle, and held Friday night music jams in the park, and Saturday morning drop-ins for garden work.

Land Use Planning in a Bill 23 World: what it means for cottage country was introduced by Deborah Martin-Downs, FOCA Vice President, with guest speaker Theresa McClenaghan, Executive Director of the

Canadian Environmental Law Association. (See link on page 1 to download the slides.) Introductory words by Deb Martin-Downs:

It is my privilege today to introduce our next topic and guest speaker. I expect that I don't have to tell you that the health and sustainability of our waterfront communities is highly influenced by the way we use the landscapes around our lakes and rivers. Some of you got involved with your lake association because of issues related to water quality, boating, or maybe because of development. Despite the idyllic cottage life we lead year round or seasonally, we must be ever vigilant about what is happening in our backyard.



What gets built and where is a function of official plans and local zoning bylaws but is driven by rules dictated by the Province of Ontario through the Planning Act and the Provincial Policy Statement (or PPS) and other associated acts. One of these provincial acts Bill 23 known as the More Homes Built Faster Act, has featured prominently in the media since it was introduced in October of last year and approved in November – one month later. The changes in Bill 23 have meant significant changes about how planning takes place in our waterfront communities, how people participate in decisions, and what kind of protections are afforded to important natural features.

There is no one better to explain the act and its implications to us than **Theresa McClenaghan**, Executive Director and Counsel with the Canadian Environmental Law Association know as CELA. FOCA has been fortunate enough to work alongside Theresa and her colleagues on many files over the years and we are privileged to have her here today to provide some perspective on our land use planning challenges.

**Climate-Ready Property Tips** was presented by Cheryl Evans, Director of Flood and Wildfire Resilience at the Intact Centre on Climate Adaptation. (See page 1 for link to slides & homeowner resources.) Introductory words from FOCA:
